

**2021 - ADJUSTMENT TO SSI PAYMENTS OF PERSONS WITH DISABILITIES AS A RESULT OF EMPLOYMENT**

**Many persons with permanent disabilities currently receive an SSI payment of \$794/mo. maximum and \$532/month if living in the home of someone else furnishing room and board. It is not true that the SSI payment will automatically be terminated when the beneficiary goes to work. Instead, when a person receives a wage as a result of employment, adjustments will be made according to the following chart resulting in more income for the beneficiary.**
